The Board was informed that according to the provisions of Rule 182(A) of the Bihar Public Works Department Code,--

10.614

"The item of work not included in the Bill of Quantity (BOQ) shall be termed as extra item. For extra item, there should always be a supplementary agreement and rate will be guided by the rate of primary agreement which means the rate approved by the competent authority at the time of primary agreement will be guiding factor for the rate of extra item. It may be lower than but in any case it should not be more than the rate quoted for the primary agreement. The rate and BOQ shall be sanctioned by the competent authority, authorized to sanction the BOQ of primary agreement but in no case the extra items agreement shall be more than 10% (item-wise and overall cost both) of the primary agreement. If it exceed by 10% then one level higher in hierarchy shall be the competent authority, if it is more than 20% (item-wise and overall cost both) then departmental approval shall be required."

After discussion, the following resolutions were passed by the Board in this regard:
