- **a.** Preference will be given to the Hotel Management background with 5years' experience to run reported Hotel/Restaurant in India.
- 2. The cafeteria will comprise VEG/NON-VEG/Fast food etc. Working hour will be from 9:00 AM to 8:30 PM.
- 3. Cafeteria Zone comprising of Kitchen and Canteen hall will be allowed to be used by him. Tenderer are advised to visit the premise before quoting rate/tender.

- 4. Cafeteria will showcase healthier and delicious Indian regional cuisines, with best Quality. Only Refined cooking oil Pure Ghee is must for use. Only fresh items will be sold at counters.
