- 10- Firm should be registered with services of an architect with valid registration no. with council of architecture Govt. of India.
- As per attached layout Plan and requirement. Tender Bid is invited in two parts (i.e. Technical bid and financial bid) should always be placed in sealed envelope, with the name of the work and due date and times written on the envelopes .The technical should contain the design Part in the form of Detailed Project Report (DPR) excluding BOQ.
- 12- The concerned firm should submit technical & Financial proposal in sealed envelopes separately super scribing on the envelop Technical /Financial as the case may be.
- 13- The Technical proposal must contain the Detailed Project Report excluding financial part. The DPR should contain detailed list of specification, plan and detailed drawings so that the evaluation of the proposal by competent authority of finance department can be made easily.
- 14- The Financial part shall contain the detailed Bill of Quantity (BOQ) with specifications.
- 15- The Financial part of the short listed firm in the technical proposal stage would be opened by B.S.B.C.C.L., Patna and the work would be awarded to the firm quoting lowest rate.
