Dear Mr. Prasad & Mr. Chaudhary,

As you know that the BISPS project is closing on September 30, 2020. In order to satisfactorily close all activities, we need to make sure that the following points are kept in mind and specific tasks mentioned therein are duly undertaken.

Expenses Eligible for Reimbursement

- a. The Bank will finance only those activities that have been physically completed till the Closing Date of September 30, 2020. In other words, expenditure will be eligible for reimbursement in respect of those activities that are physically completed by September 30, 2020.
- b. The Implementing Agencies (IAs) SSUPSW and BRDS, therefore, will need to set up a system for identification of activities that are completed by September 30, 2020.
- c. This is applicable to all types of expenses civil works, consultancies, goods and operating costs. Operating costs, salaries, rent etc., can be claimed only up to September 30, 2020.
- d. The IAs are advised to be extremely strict in the application of this rule. Any amounts identified as ineligible subsequently will result in refund of IDA funds to the Bank.

2. **Grace Period and Claims**

- a. The IAs will get a Grace Period of 4 months (i. e. October 1, 2020 to January 31, 2021) to make payments in respect of the above and effect financial closure.
- b. They must ensure that ALL claims must be filed with the CAAA on or before January 31, 2021 (or extended period) in a manner to provide adequate time for the claims to be received at the office of the World Bank.
- c. In exceptional circumstances, the Grace Period can be extended by another two months (maximum). For this purpose, Government of Bihar will need to make an application to the DEA well within time who will recommend the extension to the Bank.

Audit & Other Observations

- a. Audit will need to be conducted till the last day of the Grace Period. The due date for submission of the last and final audit report will be December 31, 2021.
- b. The IAs are encouraged to have the audit completed as early as possible. For this purpose, the IAs will ensure that the auditors are appointed and the project financial statements are provided to them timely.
- c. IAs must ensure that ALL observations made by the external auditors, internal auditors or by the Bank must be adequately addressed before the final claim.
- d. Any outstanding observations having a financial implication should be reduced from the claim OR else these may be considered ineligible and the Bank may seek a refund subsequently.

Procurement Post Review: FY-2021

a. The details of the Post Review contracts that were made from July 1, 2019 onwards are to be provided along with their STEP Contract Reference numbers. Please use the format used in the previous years for providing information.

Civil Works

- a. The IAs will ensure that all extension of time (EOTs) are processed and approved within the Closing Date of September 30, 2020.
- b. A date should be decided by which recording of Measurement Books and approvals should be completed (usually 30-45 days from the Closing Date).
- c. All completion certificates and handing over memos should be issued.
- d. Retention Money has already been claimed from the Bank. Therefore, any Retention Money remaining outstanding as on the submission of the final claim, should be reduced from the claim.
- e. The IAs may refer to the Bank's email dated August 20, 2020 in this respect.

6. Issuance of Circular to Implement the Above

a. Government of Bihar or the IAs should issue a circular at the earliest on the above matters so that all concerned are familiarized with these norms.

This is reference to your email dated July 24th, 2020 seeking our no objection to BSBCCL releasing the retention money to the Civil Works contractors who have completed the construction work of the BUNIYAD CENTRES as requested by BSBCCL in their letter dated 06th July 2020.

We have reviewed the copies of the 2 sample contracts attached with your email sent on August 19th 2020 and it is seen that the Civil Works Contracts have the provision (GCC 48.3) for the Contactor to substitute / replace the retention money with an on-demand bank guarantee and that such an option is available to the Contractor upon "Completion of the whole works".

The World Bank disbursement guidelines provide that "When the warranty period goes beyond the project closing date, the Bank will accept retention money as an eligible expenditure if (a) the contract for the work has been completed and the work has been provisionally accepted before the loan closing date and (b) the contract provides for the option of replacing the retention money with an on-demand bank guarantee or other suitable performance security".

You are advised to follow the above mentioned guidelines and ensure that the following conditions are fulfilled for the release of retention money to the Civil Works contractors who have completed the construction work of the BUNIYAD

- the contract provides for the option of replacing the retention money with an on-demand bank guarantee or other suitable performance security
- The warranty or DLP goes beyond the closing date (Sept 30, 2020)
- The contract has been completed prior to the closing date
- The work has been provisionally accepted before the closing date
- Preferably, the substitution with bank guarantee and release of retention money should happen by the closing date
