## **BIDDER QUALIFICATION CRITERIA**

## NIT 76/2024-25 (GROUP1)

#### A) Synthetic Athletic Track

The construction of the synthetic athletic track is to be completed adhering to World Athletics standards. Installation of Full PUR system synthetic athletic tracks requires high specialization and therefore, bidders need to have sufficient experience in this particular field. The following tender criteria should be satisfied by the bidder or sub contractor:

1) The bidder as a primary contractor should have supplied and installed at least Five Class-I/Class-II Certified (By World Athletics, Earlier IAAF) Synthetic Athletic Full PUR Eight lane track of 400m in India during the last 5 years in their individual capacity and not as a Joint Venture. It is mandatory to submit the track completion certificates and World Athletics certificates of class I/ Class II.

### B) Indoor Stadium

The primary bidder must have constructed at least one indoor stadium with prefab building or constructed a prefab building of span not less than 20m in India, within the last five year. The work must have been completed in their individual capacity, not as part of a joint venture. It is mandatory to submit the required completion certificates.

### C) Football Stadium

The primary bidder must have constructed at least one Natural/Synthetic Football ground adhering to Khelo India Guidelines, in India, within the last five years. The work must have been completed in their individual capacity, not as part of a joint venture. It is mandatory to submit the required completion certificates

If the primary bidder does not meet the specific conditions and experience for the specialized scope of work with respect to construction of sports infrastructure as mentioned above, then the bidder is required to submit a binding subcontractor agreement with a specialized agency that has the required experience credentials to comply with the requirement of this scope. Such a sub-contractor should comprehensively meet all the requirements/qualification conditions for the respective scope independently and not as a JV.
